PRESIDENT REPORT

To start off, with orientation we are in the midst of hiring new folks for orientation and some of you have reached out about the hiring panel. The next head gael should be hired in time for Week 6, with the chairs following that in time for week 6 as well. In terms of the head gael transition process we are working with Kristin, the human resources officer, to ensure we are following those processes. You may also notice our policy updates to ensure the process is equitable and practical for the head gael and the incoming orientation team. We are super receptive to feedback about orientation. With that being said on the feedback part we are working with the campus affairs commissioner to help streamline orientation feedback and we are making our best efforts to do so.

We have hired our interns and our intern council will be fully onboarded after the reading break. Lots of really great projects and initiatives have come out of intern council and I am excited for them.

On the note of academic advocacy, we are picking up the Thought Exchange by the end of October with Wendy Craig from the Faculty of Arts and Science and working with Alicia from the faculty commission. We have been working alongside the Faculty of Arts and Science about cyclical program reviews with both students and faculty members, and recommendations are being given for their long term sustainability. We are going to be doing lots of student outreach to faculties and how to input feedback to departments as they receive their reviews.

For National Day of Truth and Reconciliation our equity commission did a really great job from organizing events from literature to screenings and they engaged lots of students to attend and learn what they can be involved in. Congrats to Layla and I encourage you to continue that work beyond National Truth and Reconciliation Day.

A few final updates; professional development is hosting Life After Artsci and we will be working with several firms and networking with several alumni. Tickets

are going on sale before the end of this week and financial assistance is always available as well. With homecoming we are working with our sexual violence response coalitiion in terms of some programming to promote more consensual and survivor centred messaging. Governance Officer Sankaran-Wee: Next year onwards, there may be more seats from ASUS on AMS Assembly to fully represent the ArtSci student body as the largest faculty.

President Hussein: It is in compliance with what the AMS assembly policy has. It requires more Arts and Science students in the ASUS body. If no one is represented by the ASUS assembly there would be another seat in the AMS assembly. This policy is because of the AMS' most recently updated policy.

Vice President of Society Affairs Farrell: I wanted to clarify about the 20 students? And what it means by inclusive of sibling societies?

President Hussein: We have 8. Again it is the 8 reps who are from Arts and Science, and then sibling societies representatives. This is what was recommended by AMS policy and what we're adhering to at the time. Historically, we have not had 20 people representing ASUS. It is likely that it may be changed by the end of the school year or for future years.
